Samuels Library's positive impact on Warren County can be measured by the level of usage from our community. In FY24, the Library was utilized as follows:

4. Please provide a brief description of the services provided in Warren County, including program activities and description:

Print Lending Collection – The Library provides Warren County citizens access to a collection of 62,128 adult print books; 32,102 children's print books; 3,016 teen print books; and 27 periodicals.

AV Lending Collection – The Library provides Warren County citizens access to a collection of 2,566 books on CD and 9,150 DVDs.

Digital Lending Collection – The Library provides Warren County citizens access to a collection of 1,110,238 ebooks, 297,181 downloadable audiobooks, 32,171 streaming videos, and almost 15 million downloadable songs across multiple platforms such as Overdrive, Hoopla, and Freegal.

Public Computer and Internet Access – The Library provides free wi-fi throughout the building and offers access to 22 public computers with internet access and Microsoft Office software and two early literacy



computers housed in the Children's Department. There are also an additional 12 laptops to be used for programming in conjunction with the new Studio 330.

Laptop & WiFi Hotspot Kits – The Library provides Warren County citizens access to a lending collection of Laptop & WiFi Hotspot Kits. This allows patrons to access the internet and a computer in their own home as needed.

Programs for Children – The Library provides a variety of educational and recreational programs for Warren County children, including: weekly story times, crafts, STEM programs, Summer Reading, Winter Reading, Holiday Writing contest, and more. Programs are held in-person and/or virtually.

Programs for Teens – The Library provides educational and recreational programs for Warren County teens, including: teen volunteer program, monthly discussion group, crafts, Summer Reading, and Winter Reading. Programs are held in-person and/or virtually.

Programs for Adults – The Library, with assistance from the Friends of Samuels Library, provides educational and recreational programs for Warren County adults, including: professional lectures, crafts, technology assistance, database demonstrations, classes, 3 monthly book clubs, Genealogy Club, Summer Reading Program, Winter Reading Program, visits to our local Senior Center and senior groups, reading to local senior facility patients, and more. Programs are held in-person and/or virtually.

Studio 330 – The Library provides access to a brand new memory lab and makerspace located in the old computer lab. Memory Lab services allows for personal archiving. Patrons can convert analog formats to digital to preserve personal documents such as 8mm film, cassettes, VHS and more. The makerspace allows patrons the ability to access equipment such as sewing machines, laser cutter, 3d printers and more. This allows them to create things while learning new skills. Staff give one on one training sessions as well as provide programming on specific topics related to equipment etc. In addition the Library also has a booth located in the back of the adult area which patrons can reserve to record audio for projects such as podcasts or oral history interviews.

Meeting Rooms & Individual Study Rooms – The Library allows Warren County citizens to utilize public meeting spaces, including: 2 conference rooms, 2 public meeting rooms, and 2 individual study rooms.

Reference Services – Library staff are available to answer reference questions for Warren County Citizens inperson, via telephone, and via online chat. Library staff also provide 1:1 training sessions to citizens and access to a local history room.

Online Resources – The Library provides Warren County Citizens access to 7 different online resources and databases along with 51 statewide electronic collections that allow them to do business, academic, and genealogical research; sharpen professional skills; create legal documents; learn a new language; enhance their job search; and more.

Warren County Student & School Support – The Library provides services tailored to support Warren County students, educators, and homeschoolers. Public Library Connect provides public school students access to age-appropriate ebooks and audiobooks from the Library's digital collection via the SORA app. BrainFuse HelpNow provides test prep, a writing lab, live online tutoring, and a safe virtual meeting space for students. Wonderbooks are audio-enabled picture books perfect for new readers. Playaway Launchpads are educational tablets fully-loaded with games, stories, and videos that engage students and enhance literacy (no internet connection required). Library staff are available to visit classrooms or host on-site classroom tours of the Library. The Library serves as a meeting space for homeschoolers and started the Homeschool Hub, an educational program to support homeschool students. The Library also offers a special



student card to make it easier for students to access all of our digital resources, providing the student has parental permission.

Community Partnerships – The Library partners with many community organizations to provide services to Warren County residents. Laurel Ridge Community College works with the Library to offer free GED classes. Valley Health collaborates with the Library to provide online and print medical information for the community. The Virginia Department of Health partners with the Library to distribute free at-home COVID tests to the public. The Library continues to maintain the StoryWalk® at Eastham Park by changing the story book and hosting an event, with assistance from Warren County Parks & Recreation, along with the Sheriff's Department, Fire & Rescue, and the Front Royal Police Department, who have worked together to provide special story times and outdoor events for children. Warren County ARC collaborates with the Library to provide programs tailored for our special needs community. The Library has also partnered with the Warren County Office of Emergency Management to serve as a cooling/heating center for those in need. The Library's Adult Services Department is now working with the Warren Heritage Society to preserve historic documents, and to share resources and reference materials. Reference staff provide programming for senior facility patients and senior center. The Master Gardner's have a seed lending library located at our adult reference desk. The Phoenix Project provides pop-up advocacy once a month at the library.

5. Please share any ways that your agency is currently partnering with any Warren County departments:

The Library continues to maintain the StoryWalk® at Eastham Park by changing the story book and hosting an event, with assistance from Warren County Parks & Recreation, along with the Sheriff's Department, Fire & Rescue, and the Front Royal Police Department, who have worked together to provide special story times and outdoor events for children. The library also teams up with Park and Rec through-out the year on other programming events like the annual Easter event. Additionally we partner with Warren County Department of Social Services on job development programs that teach skills such as how to write a resume and complete job applications. Warren County Office of Elections & Voter Registration also has voter registrations drives at the library.

6. Please describe specifically how are using Warren County funds this fiscal year:

Samuels Public Library uses Warren County funds for the following operating expenses:

Maintenance, Utilities and Supplies - For this area of the budget, Warren County funds are used exclusively, if possible. This section of the budget includes the HVAC annual maintenance contract, monthly pest control contract, utilities, and custodial services. Additional maintenance costs are forecasted for FY26 including lawn maintenance, fire suppression inspection, emergency building maintenance.

Insurance – Covered by Warren County Funds.

Library Technology – The Library maintains 22 public computers with corresponding internet access, antivirus and lock down software – of the 22 computers, 12 are housed on the Adult side of the library and 10 are housed in the Children's Department. The Library also has laptop and hotspot lending programs. All laptops are maintained with up to date anti-virus software and lock down software, and hotspot usage is billed monthly. In addition to the 10 computers available in the Children's Department, two early literacy computers are also available on a first come – first served basis. The Library also maintains a Library Automation System which houses all patron and collection data. This system also allows the Library Catalog to be viewed and searched in house on one of 9 catalog access computers, or remotely via the Library



mobile app. All Library data is backed-up daily onsite and overnight to a cloud-based service. Library Technology is funded through State Aid, Donated Funds and Warren County funding.

Samuels Public Library will use Warren County funds for the following operating expenses:

Additional maintenance costs are forecasted for FY26 including grounds, electrical, roof, door repairs, plumbing fire suppression and extinguisher inspection.

Insurance – Covered by Warren County Funds.

Library Technology – The Library maintains 22 public computers with corresponding internet access, antivirus and lock down software – of the 22 computers, 12 are housed on the Adult side of the library and 10 are housed in the Children's Department. The Library also has laptop and hotspot lending programs. All laptops are maintained with up to date anti-virus software and lock down software, and hotspot usage is billed monthly. In addition to the 10 computers available in the Children's Department, two early literacy computers are also available on a first come – first served basis. The Library also maintains a Library Automation System which houses all patron and collection data. This system also allows the Library Catalog to be viewed and searched in house on one of 9 catalog access computers, or remotely via the Library mobile app. All Library data is backed-up daily onsite and overnight to a cloud-based service. The Library has no surplus funds from prior year funding except for the Mellon Grant which covers Cost of the Studio 330 project and employee within a 5 year period that started April 2024.

10. If requesting an increased allocation from previous approved amounts, please explain why, how your agency determined this desired amount, and what other funding streams you are utilizing to support services:

The FY2026 Budget allocation request reflects an overall increase of 16.5% from the FY2025 budget allocation per the Library Funding Agreement dated 10/03/2023. After 3 years of flat funding, during a highly inflationary period, it is imperative that we look to continuing to increase staff salaries – we are currently not even on par with the 2019 Salary Study which the County adopted. The FY26 budget includes an overall 3% increase for staff. Additionally many operational costs have continued to rise. Some examples include: from FY2025 to FY2026 we have been advised that the audit costs will increase by 25%, the HVAC maintenance contract will increased by 10% in FY2024, Health Insurance costs rose by 8% in FY2024. These examples simply serve to highlight the overall impact of inflation on all operating costs. In addition the library has now added maintenance line items back into the budget as the county has withdrawn all building maintenance assistance.

The Library will continue to support shortfalls in the budget funding through Reserve Account transfers. The Friends of Samuels Library have been very successful in their fund raising endeavors, and their funding commitments continue to rise each year.
